Recruitment of Trustees – all of the trustees are appointed or reappointed by the members at our Annual General Meeting which is normally held in Spring each year.

Remuneration of Trustees – the trustees did not receive any remuneration during the year in connection with their responsibilities as trustees.

Presidents Review of the Year

The Art Club has had a good year attracting several new members. We have had a lot of success with various classes - the monthly PaMIS/TASFife workshops for adults and young people with special needs and the Arty Bunch weekly classes for children aged 8-12 years. Unfortunately, the teenage group remains dropped for the moment as we don't have enough students, nor do we have a tutor. But we hope to resume at some point.

Our Annual Exhibition was held in our own premises this year, which gave us greater control over all aspects of the running of the exhibition. Sales of framed paintings were low, however a decent level of craft sales were achieved.

We had a table outside the Art Club when the Food Bank had their Open Weekend. This also gave us the opportunity to show any interested people around and tell them about the club.

We made some excellent sales when we had craft tables in the town centre just outside the Rothes Halls.

We look forward to continuing these successes next year.

Review of Performance and Achievements

- Our annual exhibition was held in our own Club premises this year. A great variety of artwork, both paintings and craft, were on display.
- Our art classes for the younger members of our community have remained popular. The Arty Bunch for 8-12 years has operated for most of this year. Several of our young artists exhibited their work as part of our annual Club exhibition this year.

• We have continued to develop a significant programme of art workshops this year for adults with special needs. This is being funded by Promoting A More Inclusive Society (PAMIS) on an event-by-event basis. Due to the success of this programme, we received grant funding of £1,500 from The Art Society Fife late last year to run a similar programme for children during 2023. This has proved to be very successful. It is hoped that funding will continue to allow these events to continue through 2024. Grant funding from FiFab of £350 has also contributed to the success of this programme.

Treasurers Review of the Year

Our Accounts for 2023/24 are shown at the end of this report, along with detailed Notes to these Accounts. These cover relevant accounting policies and highlight significant areas of financial performance. The previous year's figures are included for comparison.

A deficit of £17,534 is recorded in this financial year, which includes the impact of one-off expenditure of £4,200 on the repair of the lift.

It should be noted that there are only nine months' worth of Gas and Electricity invoices included in this financial year, due to ongoing discussions with our new energy supplier.

Our balance on 29 February 2024 is £48,474 which is healthy in terms of our short-term annual costs, but work continues to lie ahead in terms of increasing our income significantly or seeking to reduce our annual running costs.

Independent Examiners Report to Trustees/Members of Glenrothes Art Club (SCIO)

I report on the accounts of Glenrothes Art Club (SCIO) (SC049835) for the year ended 29th February 2024.

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) 2005 Act and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1)(d) of the Accounts Regulations does not apply. Notes to the Accounts

1 Basis of Accounting

These accounts have been prepared on the Receipts & Payments basis in accordance with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

2 Nature and Purpose of Funds

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes. The trustees maintain a single unrestricted fund for the day-to-day running of the club.

Designated funds are unrestricted funds earmarked by the trustees for particular future projects or commitments. The trustees have established one designated fund, where the proceeds from the sale of Cottar House Studio have been earmarked towards future property infrastructure costs - including business rates and property improvements within our new premises.
